

# General and Specific Terms of Use (GSTU) Live Intelligence

The hosting and operation of the Service are provided by **ORANGE BUSINESS SERVICES**, a public limited company registered with the BOBIGNY Trade and Companies Register under number 345 039 416, with its registered office located at 1, place des Droits de l'Homme 93210 LA PLAINE SAINT-DENIS.

#### **IMPORTANT**

ANY USE OF THE LIVE INTELLIGENCE SERVICE IMPLIES THE USER'S UNCONDITIONAL ACCEPTANCE OF THESE GENERAL AND SPECIFIC TERMS OF USE.

THE USE OF THE SERVICE IS EXCLUSIVELY INTENDED FOR USERS EXPRESSLY AUTHORIZED BY THE CLIENT OF THE SERVICE PROVIDER. ACCORDINGLY, THE SERVICE PROVIDER PROHIBITS THE USE OF THE SERVICE OR ANY OF ITS FUNCTIONS BY THIRD PARTIES.

## A- General Terms of Use

## **Article 1 - Definitions**

**Client:** refers to the client of the Service Provider who has entered into a contract for the provision of the Service to Users.

**Input:** refers to the data entered (e.g., *prompt*, uploaded document) by the User (excluding personal data of the User) during the use of the Service to generate an Output.

**Al Model:** refers to a *Large Language Model* offered to Users within the scope of the Service. The Service Provider may provide Users with one or more Al Models depending on the contract with the Client.

**Service:** refers to the generative artificial intelligence software made available to Users and governed by these GSTU.

**Output:** refers to the data provided by the Service during its use.

**User:** refers to the employees of the Client who have been expressly authorized by the Client to use the Service.

## Article 2 - Purpose and Duration of the GSTU

These GSTU aim to define the rights and obligations of the User within the scope of the Service's use.

The GSTU consist, in order of decreasing priority:

- The Specific Terms of Use (STU), which apply specifically to each AI Model;
- The General Terms of Use (GTU), which apply regardless of the AI Model used by the User.

In case of contradiction between the documents listed above, the higher-ranking document shall prevail.

It is specified that the different STUs shall not be contradictory among themselves, considering that each STU applies exclusively within the scope of the use of the (or the) AI Model(s) it covers.

The GTU and each STU come into effect upon the User's acceptance and remain in force throughout the duration of the Service's use.

## Article 3 - Acceptance of the GSTU

Using the Service's features implies acceptance of these GSTU.

Thus, the User agrees to read these GSTU carefully when accessing the Service and is invited to download, print, and keep a copy.

It is specified that the GSTU are referenced in the "My Profile" section via a hyperlink located at the bottom of the page and can be consulted at any time.

#### Article 4 - Access to the Service

The User must be at least 18 years old to access the service.

#### Article 5 - Use of the Service

Within the scope of using the Service, the User acknowledges interacting with generative AI software and commits to:

- Use the Service in accordance with applicable laws and not use the Service for illegal activities.
- The User specifically agrees to:
  - Not track, defame, defraud, intimidate, exploit vulnerabilities of a person, or cause psychological harm to anyone, for any reason;
  - Not resort to manipulative or deceptive techniques;
  - Not engage in profiling, deduce emotions, or classify people;
- Use the Service according to instructions and guidelines provided by the Client, for activities directly related to the Client's business;
- Comply with applicable data protection laws concerning the processing of personal data that may result from the use of the Service or that the User may access *via* the Service;
- Not provide inputs that are non-compliant with applicable laws or these GSTU;
- Not provide inputs aimed at obtaining outputs that are non-compliant with applicable laws or these GSTU;
- Not deposit or communicate inputs or outputs constituting sensitive personal data as defined in Article 9.1 of Regulation EU 2016/679 of April 27, 2016, as well as banking data;
- Not use the outputs of the Service in legal, medical, health, or tailored financial advice contexts without review by a qualified professional;
- Ensure that the User or the Client holds the rights of ownership or usage over the Inputs provided to the Service;
- Use the Service with a volume of inputs (questions and/or task executions) less than or equal to 1,000 requests per day;
- Not transfer viruses, Trojan horses, spyware, or any malicious software into the Service;
- Not share their login credentials and passwords;
- Use the Service solely through its user interface or via its API if the corresponding option has been subscribed to by the Client and not connect directly or indirectly with automated data extraction tools (e.g., "web scraping");
- When using the API to feed a conversational assistant (chatbot), inform end-users that they are interacting with an AI system.

When the User selects and/or queries one of the following AI models: GPT-4o-mini, GPT-4o, GPT-4.1, GPT-4.1-mini, GPT-4.1-nano, o3, o3-mini, these Specific Terms of Use (STU) apply.

# Article 1 - Access to the Service
