

Privacy Notice on the Protection of Personal Data Live Intelligence

The Live Intelligence platform provides access to generative AI assistants made available to your organization (company or public body) by Orange Business. This generative AI tool corresponds to a large language model (LLM) accessing a documentary corpus provided by your organization, presented as a conversational agent.

This tool allows interaction with this knowledge model by asking general and specific questions in the context of your organization's activities. It also enables uploading files and submitting questions related to those files.

Access rights to this generative AI tool are granted to you by your organization.

1. Identity and contact details of the data controller:

Your organization, which has granted your access to the tool, acts as the data controller for the purposes described below.

- Where possible, remove personal data before uploading documents.

Use of Live Intelligence must not amount to systematic personal data processing. If such a need arises, the user must contact their organization.
